



## MEMORANDUM OF UNDERSTANDING ON COOPERATION BETWEEN THE FUNDACIÓN OFTALMOLÓGICA DEL MEDITERRÁNEO (SPAIN) AND THE MEDICINE FACULTY OF THE UNIVERSITY OF JORDAN.

## BY AND BETWEEN

On the one hand, AMPARO NAVEA TEJERINA, MD, PhD, Medical Director of the Fundación Oftalmológica del Mediterráneo (hereinafter FOM), on behalf of the aforementioned in accordance with the powers of attorney signed in 2009.

On the other hand, PROF. AZMI MAHAFZAA, MD, PhD, Dean of the Medicine Faculty of The University of Jordan (hereinafter UJ), on behalf of the aforementioned.

Both representatives agree to develop cooperation activities between both institutions based on the following

## **CONSIDERATIONS:**

That UJ and the FOM agree to sign the present Memorandum of Understanding on Cooperation in the areas of care, research and teaching.

That in this Memorandum of Understanding is of particular interest the clinical training of medical students or Ophthalmology specialists from UJ in the FOM, as well as the participation in research programs.

Therefore the signatories of this Memorandum of Understanding establish the following:

## **CLAUSES**

FIRST: The purpose of this Memorandum of Understanding is to formalize the collaboration between the parties in the fields of teaching and research.

SECOND: The following types of cooperation are considered in this Memorandum of Understanding:

- 1.- Clinical training programs of medical students and medical specialists.
- 2.- Peer counseling on issues related to the activities of both parties.

3.- Exchange of ophthalmologists and researchers so they can participate in conferences and seminars, spend time as visiting scholars and share their research, teaching and clinical experiences.

THIRD: This actual Memorandum of Understanding will last for three (3) years from the date of the last signature and will be extended automatically if there is no previous cancellation demand by any of the parties. Such cancellation will have to be communicated by writing to the other party at least two (2) months before the ending of the Memorandum of Understanding or the ending of any of its extensions. In any case, the termination of the Memorandum of Understanding shall not affect the completion of the implementation of specific ongoing activities.

FOURTH: Both parties shall use their best efforts to negotiate in good faith and settle amicably any dispute that may arise out of or relate to this Memorandum of Understanding or a breach thereof. If any such attempt at resolution fails to result in a settlement, the matter may be submitted for resolution to a court of competent jurisdiction.

Having read and understood the contents of this Memorandum of Understanding, both parties will sign two copies.
